





The NDA and the 2020 Surgeon General's Report on Oral Health

On July 27, 2018, the Federal Register published a notice in which the United States Department of Health and Human Services, the Office of the Surgeon General, the National Institutes of Health, the National Institute of Dental and Craniofacial Research, and the U.S. Public Health Service Oral Health Coordinating Committee announced the commission of an unprecedented 2nd Surgeon General's Report presenting prominent issues affecting oral health.

The report will document progress in oral health since the 2000 Surgeon General's Report on Oral Health, identify existing knowledge gaps, and articulate a vision for the future and similarly as in the first report, implore all Americans to respond to the call-to-action.

The Centers for Disease Control and Prevention (CDC) Division of Oral Health, in collaboration with the Office of the Surgeon General and the Oral Health Coordinating Committee, convened by invitation only a Surgeon General's Working Meeting on Oral Health in Arlington, VA. The U.S. Public Health Service Oral Health Coordinating Committee selectively chose invited participants from a range of disciplines and perspectives both from within the dental field and from the larger medical and health care landscape with expertise, experience, and perspectives to help inform the discussion around significant oral health related topics to guide the 2nd Commissioned Surgeon's General Report. The convening which occurred in November 2018, included an Oral Health Listening Session with informative presentations and break-out sessions and workgroups.

Subsequently after this convening, the NIH/National Institute of Dental and Craniofacial Research (NIDCR) which is the lead federal agency producing the report invited public comments for consideration and inclusion of the direction of the report which centers on six general areas of focus: 1) Oral Health Across the Lifespan -Infants, Children and Adolescents 2) Oral Health Across the Lifespan- Working Age and Older Adults 3) Effect of Oral Health on the Community, Overall Well-being, and the Economy 4) Special Topics 5) Oral Health Workforce and Integration 6) Emerging Technologies and Promising Science to Transform Oral Health.

The National Dental Association provided valuable insight into the discussion at the convening session and provided integral written commentary on the six focus areas to the

Surgeon General's report team for inclusion. Additionally, since the NDA views health as a matter of social justice and civil rights, the organization submitted information on some of the NDA's key legislative and health policy priority issues from the perspective of oral health in the African American community. Lastly, the NDA also recommended and provided a list of some of the organization's most prolific oral health thought leaders as potential report contributors and reviewers. Individuals who were invited by NDA President Dr. John T. Daniels II and Board Chair, Dr. Cheryl Lee, to have their work considered for inclusion in the report are: Marsha Butler, Jennifer Cyriaque, Andre Farquharson, Nathan Fletcher, Judy Greenlea-Taylor, Hazel Harper, Clinton Normore, Kim Perry, Janet Southerland, Brian Swann, George Taylor and Fredette West. Additional names will be added to the list as experts agree to be considered as contributors to the report.

The National Dental Association is honored to have been involved and engaged with the 20th Surgeon General, VADM Jerome M. Adams, MD, MPH and lead United States agencies efforts on improving oral health. The first commissioned report in 2000 under the direction of Surgeon General David Satcher, MD, is known to be one of the most widely cited documents ever. The new report garners this same expectation and the NDA looks forward to continued participation, engagement and assistance with the Surgeon General's office and lead agencies on initiatives to improve oral health. Below are a few recent engagements.

The National Dental Association was excited that several of our NDA members were selected for this prestigious opportunity of participating in the SG Oral Health Listening Session Nov. 2018, including two of our NDA Past Presidents, Dr. Nathan Fletcher and Dr. Judy Greenlea Taylor. Both were able to add valuable insight into the discussion and look forward to continued participation and engagement of the NDA.

DTAF Awards Grant to NDA for Prenatal Oral Health Project

The Dental Trade Alliance Foundation awarded a \$25,000 grant to the National Dental Association (NDA) for a pilot project to address the alarming lack of prenatal dental care by pregnant women in the Washington, DC metro area. The NDA application was one ten selected from over 200 applications. The title of the new project is “Links to Oral Health for Expectant Moms”.

By improving access and increasing awareness about the link between oral health and positive birth outcomes, the program seeks to advance the concept of integrated, collaborative, patient- centered health care. The proposed pilot will be an expansion of NDA-HEALTH NOW®, the NDA’s signature project, and will adopt the Project’s proven and successful strategies for improving community health, including:

1. identifying stakeholders ;
2. engaging community partners;
3. developing referral networks;
4. compiling resource directories of providers and support systems;
5. cultivating community alliances and coalitions; and
6. providing technical support, volunteers and resources.

It will seek input from the target population; mobilize subject matter experts from the community; and harness the creative energies of health and non-health professionals and students from multiple disciplines. Dr. Hazel Harper Johns is the Project Director.

2019 Inter-Professional Student Leaders Colloquium and Summit



The 2nd NDA IP Student Leaders Colloquium and Summit was held January 31-February 2, 2019 in Memphis, TN. The Summit was hosted by the NDA Eddie G. Smith Leadership Institute and the St. Jude Children's Research Hospital with support from the GlaxoSmithKline Foundation and the DentaQuest Foundation.

The goals of the IP student leaders initiative are:

1. To strengthen the health leadership pipeline by identifying and cultivating ethnically and racially diverse student leaders for career leadership roles that will be transformational and positively influence systemic change;
2. To focus training on areas that characterize a transformational leader;
3. To provide leaders of tomorrow with the skill sets they will need over the span of their careers, to achieve goals that will impact systemic, social and behavioral change for improved population health;
4. To develop a program uniquely suited for leaders for whom health equity is a matter of social justice, and health leadership is a moral obligation;

5. To identify and collaborate with institutions and faculty mentors dedicated to diversity and training student leaders in their respective disciplines: medicine, dentistry, nursing, pharmacy, social work, public health, communications, business and law; and
6. To involve students in collaborative group projects.

Highlights of the program included a Welcome Reception and guided tours of the St. Jude Children's Research Hospital; opening dinner with special guest speaker, Rear Admiral Tim Ricks, DMD, MPH, U.S. Assistant Surgeon General and Chief Dental Officer of the U.S. Public Health Service; leadership training sessions and work groups; a visit to the Memphis Civil Rights Museum (formerly the Loraine Motel where Dr. Martin Luther King, Jr. was assassinated in 1968.); and several networking sessions. Student leaders invited to attend were from: Columbia University College of Dental Medicine; Howard University College of Dentistry; Howard University Schools of Communications, and Social Work; Long Island University Heilbrunn School of Nursing Long Island, Brooklyn; Meharry Colleges of Medicine and Dentistry; Morgan State University School of Community Health & Policy; Tennessee State University; and the University of Memphis. Students were accompanied by faculty advisors from their respective institutions. The leadership sessions were conducted at St. Jude's state-of-the-art Domino's Event Center.

Dr. Ricks' Opening Session presentation, entitled "Priorities in Health: Challenges and Opportunities", provided insights about the priority issues of the Surgeon General and the many resources and opportunities that are provided by the Department of Health and Human Services. The St. Jude Executive Team members



(A.C. Wharton, Richard Snow, Evelyn Homs and Darnell Clayton) gave in-depth presentations about operational aspects, development mechanisms, and talent acquisition for the unique facility. The students were divided into four work groups. Drs. Hazel Harper Johns and Alvenia Rhea Albright were co-trainers for the Leadership segments, and provided training in program development, literature review, and proposal writing (Dr. Harper Johns); and critical thinking and transformational leadership (Dr. Albright).

Each group was assigned a public health crisis issue and had to work collaboratively to develop proposals that would address the issue and provide transformative solutions to solve the crisis. They were given 4 hours to complete the assignment and 7 minutes to present the complete concept, including problem statement, recommendations, actions steps, and evaluation methods. The groups were provided with templates for a timeline, work plan and logic model. The four crisis issues were: 1) Prenatal Care Disparities Among Women of Color; 2) Perinatal Mortality-Maternal and Infant Mortality; 3) Opioid Dependent Babies; and 4) Implicit Bias in Health.

The course evaluations revealed that 100% of the participants agreed that the overall quality of the activity was excellent. And of those that agreed, 81.8% “strongly agreed”. The following comments from students will be used to further refine and implement improvements in the program:

“This course has influenced my role as a future leader by the following: (i) By acknowledging me as a leader, (ii) Enlightening /highlighting steps to leadership pathways, (iii) By providing a framework a la NDA in which other leaders have succeeded”

“This course empowered me to call myself a leader. I always try to be humble and although I convey leadership roles, I never called myself one.”

“This symposium made me feel that I need to do more. I need to be the change I want to see.”

“Dental health is vital to prenatal care.”

The evaluation summaries, especially the comments, are clear indicators of the success and impact of this program in its second year.

About St. Jude:

Founded in 1962 by entertainer Danny Thomas, St. Jude is a hospital for children with cancer and catastrophic diseases that cannot be cured at any other institution. Danny Thomas selected Memphis because, at the time, Memphis was considered to be the epicenter of the poverty belt. Danny Thomas was a champion for civil rights and was determined that everyone would work together to create a “Family” of committed persons devoted to the dream. In fact, St. Jude became the first desegregated hospital in the south...because of Danny Thomas. The campus, designed by Paul Williams, a Black architect and a member of Omega Psi Phi Fraternity, consists of forty buildings, including a hospital, research center, and ASLAC (the fundraising and development entity). There are 3,000 employees working on fundraising mechanisms that generate the \$900M per year needed to operate the mammoth organization. The organization also has three housing units to serve the families of the patients, and it provides payments for all hospital costs, housing, meals, and transportation all family members for up to five years.

The very first grant that St. Jude received was for Sickle Cell Anemia and it was the FIRST institution to cure a patient with sickle cell disease. It was done with a bone marrow transplant, and today that is the only Sickle cell cure. Today, 40% of the patients are African American. It is the only entity that is supported by ALL NINE of the African American Greek letter organizations, and it has over 30 regional offices across America.




NDA Conducts 4th Annual Community-Based Training Program For Nurses at GNYDM



This year at the 2018 Greater New York Dental Meeting, the NDA continued an innovative program for nursing students that began three years ago at the 2015 meeting. Since that time, 151 nursing students have completed the training. The program was underwritten by the Aetna Foundation as part of the ongoing partnership between the NDA and Aetna for inter-professional education.



It is titled **INTER-PROFESSIONAL COMMUNITY-BASED LEARNING – ORAL HEALTH and NURSING: A TEAM APPROACH to POPULATION HEALTH**. The program spanned four days, from November 25, 2018-November 28, 2018, and included lectures, hands-on training for oral screening, volunteer orientation on the Colgate van, participation in the Greater New York Smiles children’s program, the GNYDM Adult Health Screenings, and guided tours of the GNYDM technical exhibit hall. Special guest visitors included Dr. Marc Gainor, general chairman of the GNYDM; Dr. Marsha Butler, Vice-President Global Professional Relations & Marketing, Colgate-Palmolive; Mr. Michael Cohen, Senior Scientific Engagement Liaison, Oral Care, US, Johnson & Johnson; Ms. Susan Masullo, CarrotNewYork; and Mr. Derrick Humphries of law firm Humphries & Partners, PLLC. Also, in attendance were several members of the New York chapter of the Links, Inc. Many national partners of NDA-HEALTH NOW® (Health Equity, Access, Literacy, Technology and Hope. National Outreach on Wheels) and Advisory Committee members of NDA-HEALTH NOW-New York® supported the unique program with resources, in-kind donations, speakers, trainers, and volunteers. We are especially grateful for the donations received from **SUNSTAR, Henry Schein Cares, the Greater New York Dental**

Meeting, and Columbia Dentoform; and for the enthusiastic participation of the Columbia University School of Nursing and New York University College of Nursing. Others contributing to the program’s success were: Dr. Jose Liens, NYPH/Columbia General Practice Residency; Dr. Christina Becco, BronxCare Health System General Practice Residency; Dr. Shaun Massiah, Upper Westside Dental Group; and Dr. Tricia Quartney, President of the Greater Metropolitan New York Dental Society. Under the leadership of Dr. Robert Edwab, Executive Director, the GNYDM Team provided a very unique experience for the nursing students and phenomenal support for the program. The program presenters were Dr. Hazel Harper, Founding Director, NDA-HEALTH NOW®, Dr. Dominique Juste and Ms. Terri Rivera, Colgate Bright Smiles/Bright Futures; and Dr. Nicole Cheek, Special Projects Assistant, National Dental Association. The topics included: 1) “Tips and Techniques for Oral Screening, Oral Hygiene & Oral Health Education [Hands-On Participation]; 2) “Razzle Dazzle Smiles Across Generations™”- overview of oral health, systemic health and oral care products; 3) Intro to Mobile Dentistry (Colgate Van and Bright Smiles Bright Futures program); and 4) Exhibit Hall Guided Tours. This year, the program expanded to include Maternal and Child Oral Health with presenter Dr. Mary Lee Conicella, Aetna’s Chief Dental Officer, and her presentation “Prenatal Dental Care and Birth Outcomes: The Alarming Impact of Benign Neglect.” Dr. Conicella’s presentation included Aetna’s most recent data connecting oral health to dental visits and birth outcomes. In addition, Dr. Harper also delivered a presentation on the same subject, entitled: “Links to Oral Health for Expectant Moms”, the title of the new NDA pilot project in Washington, DC funded by the Dental Trade Alliance Foundation.

Dr. Jennel Osborne, a nurse who had previously attended the NDA Inter-Professional Student Leaders Summit in 2017, was welcomed as the first NDA-HEALTH NOW® Fellow. After attending the 2017 IP Student Leaders Summit in DC, Dr. Osborne volunteered to participate in the annual community service activities held at the Greater New York Dental Meeting

last year. She attended oral health lectures on community-based learning for nurses conducted by the NDA-HEALTH NOW® Project, where she participated in the hands-on training sessions; received instruction in the fundamentals of oral health and oral hygiene; and learned how to perform oral screenings by practicing on other nursing students in attendance. Soon, Jennel was assisting with the nurses training- directing and providing oversight for oral health techniques she had just learned! In addition, she volunteered to spearhead the Blood Pressure area at the adult health fair, developed a B/P screening tool for data collection, wrote a report, and provided recommendations for this year's, and next year's, health fair. The course evaluations revealed that of the 11 students who attended, 100% responded that they felt this training would make them a better health team member and all of the students either "agreed" (9.1%) or "strongly agreed" (90.9%) that they learned something that they didn't know before. When asked if this information/training should be required for all nurses and other non-dental health professionals, 100% agreed that it should. Of these, 81.8% "Strongly Agreed" that this type of training should be required for all nurses and other non-dental professionals. 100% indicated that they would recommend this course to other nurses and other non-dental health students. In gauging how much more likely they were to do oral screenings now that they had this training, respondents indicated that they are 93.6% more likely to perform oral screenings, which would not have been the case without this training!

Of particular significance was that 100% of the Pediatric Nursing students agreed that this training would help them promote oral health with their pediatric patients. As a result of their participation in the Greater New York Smiles children's program and Adult Health Screening, 100% of the nursing students replied that they are now more likely to participate in

future community outreach programs or health fairs. And when asked if, as a result of this training course, they would now be more likely to include "Oral Health" in their own health fairs, 100% of those responding said "Yes!"

The following students' comments provide the impetus for additional programs:

"Come to NYU Meyers and give a presentation to spread the word!!! Anything to help with scheduling would be helpful as well - full-time students are very busy on Mondays-Wednesdays :- (This was such a great experience, and I'm positive more students would be involved if they knew more information about it. Everyone was so kind, helpful, and a joy to spend time with!!!"

"Training course was highly practical, especially the demonstrations. I expected to do more oral examinations then after, but I realized the importance of oral screening to be implemented in my nursing career."

"Course is great, very informative. I think that collaboration between initial evaluator (nurse) and dentist can be further emphasized and discussed in training. Otherwise, great work and I'm looking forward to seeing the great work that you do!"

"Actually incorporate dental into primary care practice"

"I enjoyed the training course and thought it was very informative. I appreciated that dental professionals would take the time to speak to nurses to educate them on the importance of dental screening."

Most recently, the project was referenced in the American Journal of Public Health article, "The Aetna-NDA Partnership for Achieving Racial and Ethnic Health Equity", which details the partnership between Aetna and NDA. 

Protocol Corner

For this month's Protocol Corner, I would like to discuss several topics I believe are important for the National Dental Association.

When our constitution was revised in the 1990s, the House of Delegates (HOD) and Board of Trustees (BOT) reflected our membership in size and participation. We are now in a different time with our membership. Unfortunately, our current membership size and governing structure seems out of balance. The HOD passed a constitutional change a few years ago to decrease the BOT size by one trustee per district to ensure greater participation. Board attendance and commitment has increased as a result of the change. I suggested during a recent executive committee meeting we consider the idea of restructuring our organizational flow chart to accommodate our membership stature.

Another change which is being considered to our constitution is our "Life Membership" application age requirement. We all appreciate the value of life membership to any organization. However, many of us "baby boomers" are practicing and living longer. The age requirement for life membership is 62 years of age. We know sixty-two is relatively young in today's world. People are living well into their 80s and in some cases practicing into their 70s. It has been proposed by the BOT during our 2018 Transition meeting to increase our life membership age requirement to 65 years of age. No action has taken on this proposal as this still has to be approved and voted on by the HOD. Changing this will also have a positive economic impact for the NDA considering the fact life members don't pay membership dues. The possibility of having an influx of non-dues paying members should concern everyone.

Finally, to wrap this article up, I'm sending out a request for your help. I'm sending this to all members not just those in leadership. On our website, we have listed our position papers, and some of ours have not been revised in some time. I am asking YOU to take the time to review a paper and provide current evidence based literature for sections that require updates. Your efforts will be greatly appreciated. I know we have plenty of expertise within our ranks. We could use immediate help with position papers on opioids and fluoride. We are all aware these are two topics in the forefront of our profession. We need to have a voice with our thoughts on these important subjects, and unfortunately, we have a limited number of HOD members with this expertise. Baseline Evaluation of Amalgam and ART Restorations in the Population of Nuqui, Colombia

Objective: The aims of this study were to compare 2-year cumulative survival rates of amalgam and atraumatic restorative treatment (ART) restorations in primary and permanent teeth and to investigate the determinants of the survival rate of restorations.

Method: A pilot clinical study using a parallel group design was carried out on 60 participants aged 5 to 83 years-old in Nuqui, Choco, Colombia with at least one carious primary or permanent tooth to clinically evaluate single and multiple-surface ART and amalgam restorations at baseline. Assessments were conducted using a quality evaluation protocol to assess the clinical outcome of each procedure. Two dentists placed the restorations, which were clinically evaluated for marginal adaptation, anatomical form and caries at the cavosurface margin by one of them at baseline. Restorations were placed in vital primary and permanent teeth with neither pain nor signs of pulp involvement; anesthesia was not used during the clinical procedures. A questionnaire was used to collect demographic information from the participants.

Results: The population consisted of 38 females and 22 males who were 95% black Colombians and 5% indigenous Colombians. The baseline report showed 24 amalgams (40%) and 36 ART (60%) restorations. One and two surface ART restoration procedure times ranged from 10 to 20 minutes; three-surface ART restorations were 15 minutes. One-surface amalgam restorations ranged from 10 to 25 minutes; two-surfaces from 10 to 30 minutes and there were no three-surface amalgam restorations. In summary, there were 13 one-surface ART, 21 two-surface ART, and 2 three-surface ART; 18 one-surface amalgam, 6 two-surfaces amalgam, and 0 three-surface amalgams. The clinical evaluation showed no differences in the baseline quality of ART and amalgam restorations.

Conclusion: Amalgam and ART restorations did not present clinical differences in the quality of single-surface, and multiple-surface restorations at baseline.
